### **BENEFITING THE ALBUQUERQUE FAMILY ADVOCACY CENTER**

The Family Advocacy Center was established through a joint partnership between the City of Albuquerque, United Way of Central New Mexico, Albuquerque Regional Businesses and Crisis Service Providers. The Center houses 14 different organizations that help both adult and child victims of violence; intimate partner violence, child abuse, sexual assault and rape. It houses both government and nonprofit service providers under one roof to make it easier for victims to get access to services they need to improve their lives. Victims can come to the AFAC and decide which services they want and which they do not. Services are selected by the victim and are free.

The onsite partners provide advocates, legal services, court services, crime victim reimbursement, forensic interviews, sexual assault medical exams, and include the D.A.'s office, crisis workers, and child protective services in addition to law enforcement. Specialized services are available to victims who have additional barriers related to language, culture and/or disability.

The mission of the Family Advocacy Center is as follows:

*A Family Advocacy Center is a facility where adult and child victims of interpersonal violence and sexual assault have access to comprehensive, multi-disciplinary services. The focus of the AFAC will be to decrease victim trauma and intimidation while providing supportive services in respectful and culturally appropriate ways.*
